## Notice of Outreach and Public Hearing to Extend Fiscal Year 2022 Pandemic Recovery Program

The San Francisco Bay Area Water Emergency Transportation Authority (WETA) is seeking public input on the proposal to **extend the Fiscal Year 2022 Pandemic Recovery Program**. If the proposal is approved, fares would remain the same for another year, through June 30, 2023.
